At TPC each Elder serves on a committee and has a vote at monthly Session meetings. Current committees are: Administration & Human Resources, Christian Formation, Fellowship, Membership, Outreach, Property, Stewardship & Finance, and Worship. Elders may serve up to six consecutive years. The Session consists of nine Elders, and in addition may include one high school age Youth Elder.

Recommendations are solicited for Elders for 3-year terms commencing April 1, 2026 and ending March 31, 2029 1-year term for Youth Elder, commencing April 1, 2026 and ending March 31, 2027.

CONGREGATION NOMINATING COMMITTEE

The Congregation Nominating Committee consists of one member of the Session, appointed by the Session, one Deacon appointed by the Board of Deacons, and three members of the congregation (not currently serving as church officers) elected by the congregation for 1-year terms; the pastor is an *ex officio* member with no vote. (TPC Congregational Rules X; PCUSA Book of Order G-2.0401).

The Committee identifies individuals eligible and willing to serve as Elders, Deacons, members of the Congregation Nominating Committee, and members of any Pastor Nominating Committee and proposes a slate of nominees to the Congregation for election. Members of the Congregation Nominating Committee may serve up to six consecutive 1-year terms.

Recommendations are solicited for persons **not currently serving as church officers** to serve as congregation representatives on the Congregation Nominating Committee for a 1-year term commencing April 1, 2026, and ending March 31, 2027.
